	<ul> <li>Parking 2014/2015</li> <li>2.1. Ms. Blumenthal outlined the issues related to the current parking assignments in the Forcina Parking Garage (Lot #17-upper level and Lot #18-lower level). Currently, Lot 17 is assigned to commuters and Lot 18 is assigned to faculty/staff. There have been numerous complaints by the faculty regarding this assignment and the issue was referred to the Parking Task Force for review and recommendation.</li> <li>2.2. The Parking Task Force conducted surveys of faculty/staff and students regarding parking usage, reviewed parking statistics and parking lot availability and was unable to make a recommendation regarding the use of lot 17. The issue was referred to this Council.</li> <li>2.3. The Council reviewed the information and had a robust discussion regarding many issues surrounding parking including but not limited to graduate assistant parking status, special placards for School of Education faculty, increased commuter demand resulting from a projected increase in the freshmen class for 2014/2015, closure of Norsworthy, loss of parking lots for Campus Town and the rights of faculty, staff and students to preferred parking. The Council voted as follows on three options:</li> <li>2.3. Lot 17 should be a full commuter lot – 2 votes</li> <li>2.3. Lot 17 should be shared commuter and faculty staff – 2 votes</li> <li>2.3.4. In addition a motion was approved that would give spaces in Lot 4 to commuters, with the understanding that there would be no overall decrease in faculty-staff spaces.</li> </ul>	Dolly
